- *Seek to identify credit union needs for favorable legislation and regulation, both at the state and federal level, to enable credit unions to better serve their members.*
- *Recommend to the League Board for adoption a "Legislative and/or Regulatory Agenda" reflecting these credit union needs.*
- *Review annually existing League legislative and regulatory priorities and recommend any needed changes.*
- *Respond to legislative and regulatory action calls when requested.*
